The disaster declaration includes the following counties: Hillsborough, Pasco and Pinellas counties, and the adjacent counties of Hardee, Hernando, Manatee, Polk and Sumter in Florida.

Applicants may apply online using the Electronic Loan Application (ELA) via SBA's secure website at <https://disasterloan.sba.gov/ela>.

The filing deadline to return applications for physical property damage is **Nov. 30, 2015**. The deadline to return economic injury applications is **June 29, 2016**.
