You must submit a TRA application and be enrolled in an approved training program to receive Trade Readjustment Allowances (TRA). (See Section 231 of the Trade Act of 1974.)

If you are not on enrolled in an approved training program, you must have a waiver from the training requirements prior to your "enrolled in training" deadline.

Failure to submit an application for TAA training, enroll in approved training, or receive a waiver from training from the following deadline may disqualify you from receiving the TRA benefits.

Basic TRA - The deadline is the later of the last day of the 26<sup>th</sup> week after the date of certification issued by the Secretary of the U.S. Department of Labor the 26<sup>th</sup> week deadline is [August 04<sup>th</sup> 2012 ] or the last day of the 26<sup>th</sup> week following the official date of separation from the trade-affected employer.

\* If you receive a waiver from the training requirement, you are required to be actively looking for work.

Additional TRA - Have exhausted UI benefits. You must have met the eligibility requirements for Basic TRA then exhaust Basic TRA benefits. \*You must be participating in an approved full-time training.

Completion TRA -You must have exhausted UI benefits and met the training enrollment deadline for Basic TRA training. Exhaust Basic and or Additional TRA eligibility. You must also meet all of the following five additional criteria: (1) The requested weeks are necessary for you to complete a training program that leads to completion of a degree or industry-recognized credential (2) You must be participating in training in each such week; (3) You have substantially met the performance benchmarks established in your approved training plan (e.g. you have maintained satisfactory academic standing and are scheduled to complete training within your training plan's specified timeframe) (4) You must continue to make progress toward the completion of the approved training and (5) You must be able to complete the training during the period authorized for receipt of Completion TRA
